Privacy Policy

1. We respect your privacy

KSR Partners Pty Ltd (KSR) respects your right to privacy and this policy sets out how we collect and treat your personal information.

“Personal information” is information we hold which is identifiable as being about you.

2. What personal information we collect

We may collect the following types of personal information from you:

- Name, Job Titles
- Address
- Email Address
- Phone Number (mobile and landlines)
- Fax Number
- Date of birth and gender
- Tax File Numbers, ABN's and other government issued identification numbers
- Bank account details, shareholdings and details of investments
- Details of superannuation and insurance arrangements

- Personal information about your spouse and dependents
- information from enquiries you have made
- communications between us
- credit card information

3. How we collect your personal information
